CALIFORNIA CLASS PRIME

The PRIME fund is a stable \$1.00 NAV ("net asset value" also a pershare-value) local government investment pool that offers daily liquidity. Investments are made in accordance with California State Code and include U.S. Agencies and Treasuries, commercial paper, collateralized bank deposits, money market funds, and more.

Participation is available to any California public agency under California Government Code 6500 and 6509.7. Investments are made in accordance with California Government Code Section 53601 and the California CLASS Investment Policies.

District staff recommends diversifying the investment portfolio to include CLASS Prime Fund. Staff recommends weighting the funds toward CLASS initially as interest rates are rising and CLASS interest compounds daily. When interest rates drop, the district will re-distribute funds weighted toward LAIF as the interest compounds quarterly in this fund.
